Enrolment for Winter Academy

Selected applicants will be notified of their acceptance within <u>two weeks</u> after submitting the application. After receiving the notification of acceptance, the applicant should pay the tuition fee within two weeks.

Applicants receiving financial assistance from third parties for participation in the Winter Academy are responsible for ensuring that all payments are made by the dates specified to secure participation.

If you need a visa to stay in Cambodia, you have to apply at the Cambodian Embassy for a visa immediately after receiving the notification of acceptance. Please note that visa applications can also be done online via: www.mfaic.gov.kh. Please do not hesitate to contact us for any assistance.

Cancellations and Refunds

Any cancellations have to be made 30 days prior to starting of the course, and any fees paid by that date will be refunded (less a transaction fee of USD 30). Fees for later cancellations will only be refunded if a waitlisted applicant can take up the place.

Costs and Payment Details

The fee for the Winter Academy is 3.500 USD.

The fees include all training materials, full-board accommodation for the days of the training, site visits, social programme as well as the transfer to and from the Siem Reap Airport.

Our Winter Academy is fully tuition-based and not sponsored. Accordingly, participants must cover the full costs of the training and/or find a sponsor for their participation.
